## **SECTION RULES:**

1. Entry Forms available from Bell Bunya Community Centre, 71 Maxwell St (Cnr Wallace and Maxwell Streets), Bell Qld, phone 0497 588 546 or bellartgroup@gmail.com

- 2. Entry Form, together with Entry Fee, must be lodged with Bell Art Group, PO Box 24, Bell QLD 4408 on or before Friday 9th February 2024. Late entries may not be accepted.
- 3. Entries must be left at the BELL BUNYA COMMUNITY CENTRE (not the Bell Show Pavilion) on or before 23<sup>rd</sup> February 2024, during the Community Centre opening hours (9am 2pm) or by prior arrangement.
- 4. Responsibility rests with the exhibitor to ensure that EXHIBITS MUST BE ABLE TO BE HUNG SAFELY. NB "D" hooks are essential. Stewards reserve the right to reject exhibits considered unsafe.
- 5. Exhibits must be clearly labelled on the back, with Artist's name, address, phone number, title of work, plus Class, ie section KA1 Local or KA2 Open
- 6. Please indicate if "not for sale" or "for sale plus price" on the Entry Form
- 7. All reasonable care will be taken with each exhibit, but exhibit shall at times be at the risk of the exhibitor. The Bell Show Society and Stewards will not be liable for any loss or damage if and howsoever it occurs.
- 8. Exhibits at the Bell Show Pavilion must be collected from the Pavilion between 3pm and 4pm Sunday 3rd March 2024 once signed out by the Steward on duty.
- 9. Paintings with wet paint will not be accepted.
- 10. Each exhibit must be the original work of the Exhibitor and not have won a first prize at any previous Bell Show. NB "original work" means the entry must not be copied. Works produced under the tutelage and/or at workshops will not be eligible and the Show Society Stewards rely on the integrity of the artist. However, responsibility for establishing the authenticity lies with the artist, not the Show Society Stewards.
- 11. Judge's decision will be final and no correspondence entered into.
- 12. Exhibits must have been completed in the previous three years and be entered into one class only.
- 13. Stewards are responsible for hanging exhibits and demounting exhibits.
- 14. The Stewards reserve the right to reject or remove works considered unsuitable, and their decision is final.
- 15. Commission on sales 15%, to be paid to the Show Society.
- 16. Diptych and Triptych works need to be secure together as one art work and must meet the safe hanging requirements.
- 17. Size limitation: Size of Exhibit is not to exceed a maximum of 100cm x 100cm, including frame.
