Challenge on Saturday 2<sup>nd</sup> March 2024. We anticipate an 8.45am start for Ring Events.

FORMS: All competitors must complete a Nomination Form, Biosecurity Horse Health Declaration, and

**Waiver and Indemnity Form** for all horses on the grounds, whether competing or not. Forms are attached and can also be found on our website. All forms must be signed on the day of entry and handed in to Stewards in the horse ring prior to commencement of horse ring events. Non-

compliance may mean that your horse may not compete at the Bell Show.

Fireworks will be featured at the 2024 Bell Show on Saturday 2<sup>nd</sup> March 2024. Please take responsibility for your own animals.

### **HORSE AND RING EVENT REGULATIONS:**

- 1. In the case of any exotic animal disease outbreak occurring prior to, or during the show, all equine animals must remain at the Showgrounds and abide by the Biosecurity Qld DAFF rulings and guidelines at that time. All costs incurred are to be borne by the exhibitor and in no way is the Bell Show Society liable for expenses in case of lock-down.
- 2. Horse Health Declarations and Indemnity Forms will be required at the time of purchasing entry tickets
- 3. The Chief Ring Steward shall have the final say in all decisions regarding the event and entrance into events. The Chief Ring Steward has the ability to alter or remove any event in the Bell Show Schedule
- 4. Grooms and competitors must obey orders of the Stewards otherwise they will be fined or ejected from the grounds.
- 5. If, in the opinion of the Judge, any horse or pony is entered in the wrong class, the Judge will have the power to classify it in the correct class.
- 6. All persons shall pay for admittance to the show the sum prescribed, unless otherwise provided with a Pass from the Secretary.
- 7. All colts and stallions, 2 years of age and over, must be shown with a bit in the mouth and a safe head stall and lead. These requirements are to be to the Stewards' satisfaction. All stallions must be controlled by a person 18 years of age or over. No stallions allowed in hack classes unless specifically stipulated.
- 8. All horses age relative to 1st August. Competitor age is relative to Show date.
- 9. Unless otherwise stated all entries in breed classes must be stud book registered or recorded in accordance with the rules of the respective breed societies. Registration papers (where applicable) must be available at the show as proof of registration upon request. Exhibitors must be current financial members of the respective breed society for which they are showing.
- 10. Stewards will collect tickets immediately before judging and will present prize money and ribbons to the place getters after judging.
- 11. Exhibitors are requested to fill in tickets before entering ring.
- 12. Unused or written on tickets will NOT be refunded so please choose events carefully.
- 13. Bookings for stables/stalls will not be taken by Show Committee due to the limited number available. Competitors are advised to bring their own panels or appropriate fencing to secure their stock if camping over-night. No horses to use cattle yards for penning prior to or during the show.
- 14. Suitable attire and footwear must be worn in the ring. Singlets, thongs and similar attire are not permitted. No young children/prams allowed in the ring. Children under 18 years must wear helmets.

- 15. Stewards and Officials have the right to evict any entry in the Horse Ring which may appear to be ill, is of questionable soundness or is acting in an unsafe and uncontrollable manner. The Show Society reserves the right to reject any nomination without explanation.
- 16. Bell Show Society recommends competitors have their own current public liability policy if showing animals.
- 17. Exhibitors are not to transport any horse showing signs of illness onto the Showgrounds or knowing these animals have been in contact with other horses which have contracted any illness/disease prior to the event.
- 18. MAIDEN: A horse that has never won first place in a Hack/Show Hunter class at an affiliated Agricultural show.
- 19. MAIDEN STOCK HORSE: A horse that has never won first place in a Stock Horse Challenge or similar type event at an affiliated ACA event.
- 20. OFF THE TRACK: A thoroughbred horse retired from racing as at show date.
- 21. NOVICE: A Horse which has never won a champion open hack class at any show.
- 22. SHOW HUNTERS: May only compete in hunter classes unless otherwise specified.
- 23. ANY OTHER BREED: Exhibit must not have shown in any other breed class at this show.
- 24. PONIES: Ponies not exceeding 14 hands unless breed specifics. No Stallions in hack or rider classes unless specified.
- 25. GALLOWAY: Galloways over 14 hands and not exceeding 15 hands. No Stallions in hack or rider classes unless specified.
- 26. HACKS: Hacks over 15 hands. No Stallions in hack or rider classes unless specified.
- 27. All protests must be lodged in writing within 15 minutes of completion of the class to the Chief Ring Stew and accompanied by a cash deposit of \$50.00, such amount to be forfeited if the protest be considered frivolous or vexatious.
- 28. All pony club events in program must be current financial membership of Bell Pony Club.
- 29. LOCAL: Anyone living in the 4408 POSTCODE areas of Bell and Cooranga North.
