ELIGIBILITY FOR STATE FINALS:

- Competitors for YJ&P must be aged 15 and under 25 years on the 1st May in the year of the State Final
- Finalists can only represent one Sub-Chamber (being the first)at State for each competition.
- Qualifiers are taken from their first placing at first show of competition thereafter 2nd, 3rd placings may have the opportunity to compete.
- Qualifiers will be notified by the Sub-Chamber.
- Dust Coat essential for Paraders.
- Competitors to supply own cattle for Paraders PLEASE do not request Schools in attendance to supply you with an animal on the day. Darling Downs sub chamber cannot supply an animal for Paraders.

NON - QUALIFER (OPEN) events for Young Judges & Paraders will also be conducted STUD BEEF YJ & PARADERS & PRIME BEEF YJ.

Two categories: Under 15 years AND 15 years and under 25 years.

The Jensen/Day Stud Beef YJ Shield will be awarded for the Annual Schools Competition.
